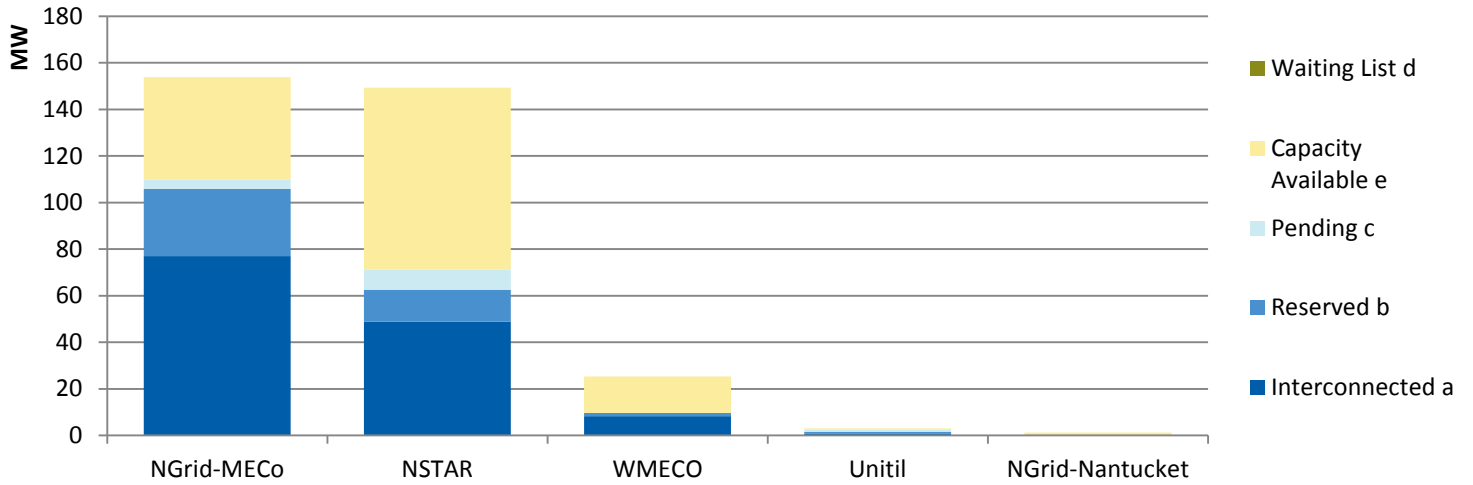

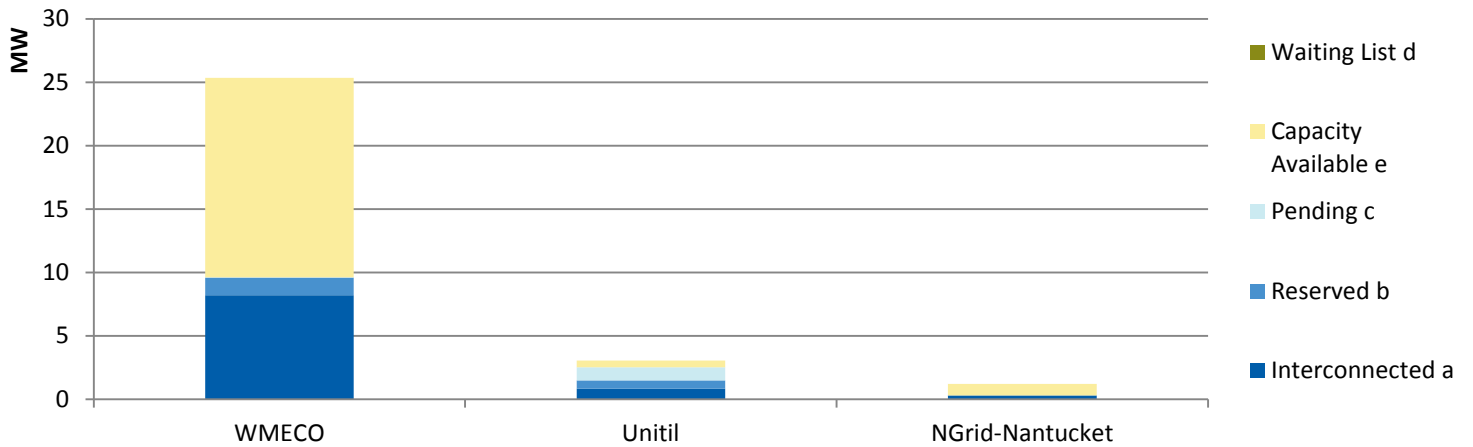
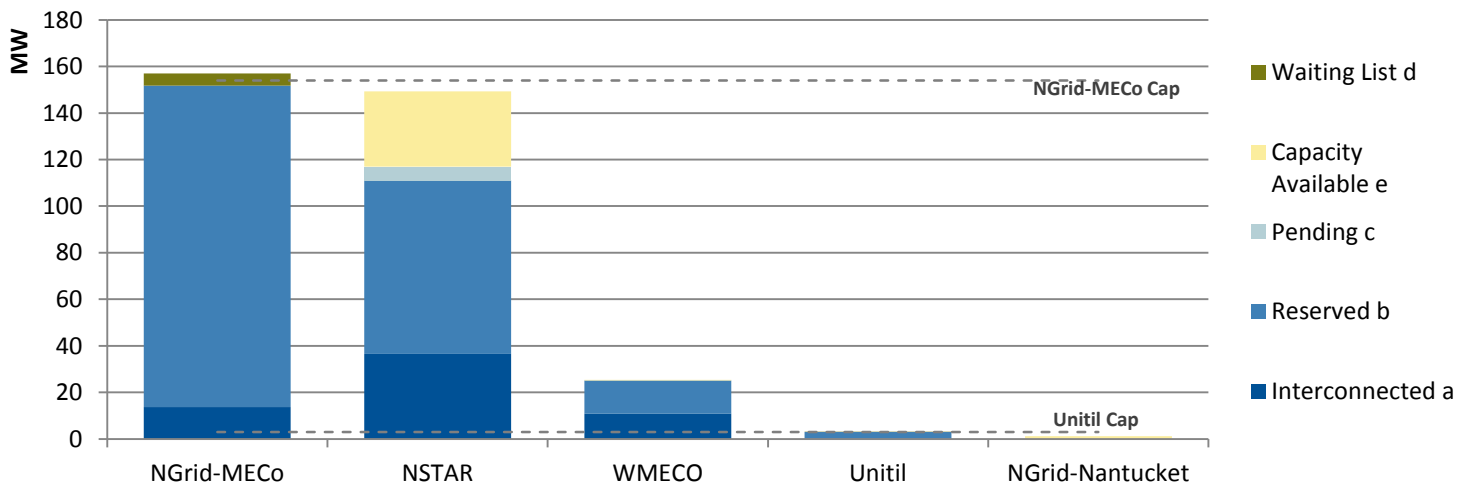


Table 2: Capacity under the Public Cap (Values in MW)
